A regular meeting of the City Council of the City of Valentine, Nebraska was held January 12, 2023 at 6:00 p.m. in the City Library Meeting Room, the same notice of meeting was given according to law. All of the proceedings hereafter shown were taken while the meeting was open to the public. A public information council agenda packet was available at the public information table. Notice of the Open Meetings Act was provided as required by law.

Council President Kyle Arganbright opened the meeting with the following Council members in attendance: Ross Brockley, Brad Arnold, Neil Wescott, Kalli Kieborz. Also in attendance were City Manager Shane Siewert and City Clerk Deanna Schmit who recorded the minutes.

Councilmember Kieborz made a motion to approve consent agenda items: #2a) Regular Library Board meeting minutes of December 27, 2022; #2b) Regular Golf Course Board meeting minutes of November 14, 2022; #2c) Regular Cemetery Board meeting minutes of November 3, 2022; #3a) Regular City Council meeting minutes of December 8; #4) November, 2022 Financial Reports; #5) December, 2022 Receipt Report; #6) December 2022 Claims & Payroll. Councilmember Wescott seconded the motion. Voting yes: Ward, Kieborz, Wescott, Arganbright, Brockley. Motion carried unanimously.

Councilmember Arganbright made a motion, seconded by Arnold, to approve submission of the Civic and Community Center Financing Fund Pre-Application for city gym renovation. Voting yes: Kieborz, Arganbright, Arnold. Voting no: Wescott, Brockley. Motion carried three to two.

Councilmember Kieborz made a motion, seconded by Arganbright, to submit the Phase One plans for the interceptor sewer to NDEE and the water to NDHHS. Voting yes: Wescott, Arganbright, Arnold, Brockley, Kieborz. Motion carried unanimously.

No action taken concerning the Rural Workforce Housing Land Development Grant Application.

Discussion was held concerning snow removal procedures.

There being no further business before the council, Council Chairperson Arganbright declared the Valentine City Council meeting adjourned at 7:09 p.m.
