MINUTES OF MEETING OF THE CITY OF VALENTINE PLANNING COMMISSION August 2, 2021

A meeting of the City of Valentine Planning Commission was held at the Valentine City Library Meeting Room, Valentine, Nebraska, on Monday, August 2, 2021.

Chairman Arganbright called the meeting to order at 7:00 P.M. and pointed out that a copy of the Open Meetings Act was posted on the North wall for anyone wishing to examine the document and directed the roll be called:

Constituting a quorum of the Members of the City of Valentine Planning Commission.

Chairman Arganbright opened the public hearing at 7:00 P.M. for the purpose of hearing public comment regarding considering reducing the rear setback requirement in the Light Industrial District alongside of a lot abutting a "TA" or "R" District from twenty-five (25) feet.

Public hearing was held.

Chairman Arganbright read aloud the first agenda item: Review/Discussion/Action: Recommendation to approve or deny Ordinance No. 2021-2253M, AN ORDINANCE OF THE CITY OF VALENTINE, NEBRASKA AMENDING ARTICLE 12, SECTION 12.2 OF THE VALENTINE ZONING ORDINANCE OF THE MUNICIPAL CODE OF THE CITY OF VALENTINE, NEBRASKA, ORDINANCE NO. 2016-2200M, BY AMENDING SECTION 12.2 TO CHANGE THE REAR SET BACK FOR LOTS ABUTTING A "TA" OR "R" DISTRICT; TO PROVIDE FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; TO PROVIDE FOR PUBLICATION OF THIS; AND TO PROVIDE WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT.

Discussion was had.

Kurt Arganbright moved to recommend approval of ORDINANCE NO. 2021-2253M to take effect as soon as possible.

Neil Muirhead moved to deny the subdivision plat because utilities shall be provided by the developer and that was not going to happen.
