## MINUTES OF MEETING OF THE CITY OF VALENTINE PLANNING COMMISSION November 1, 2021

A meeting of the City of Valentine Planning Commission was held at the Valentine City Library Meeting Room, Valentine, Nebraska, on Monday, November 1, 2021.

Chairman Arganbright called the meeting to order at 7:06 P.M. and pointed out that a copy of the Open Meetings Act was posted on the North wall for anyone wishing to examine the document and directed the roll be called:

Lot 3 Replat of Lot 2 and Lot 3 Borman's Third Addition to the City of Valentine, Nebraska (FKA 4.118 Acres located in part of the Northeast quarter of Section 6, Township 33, North, Range 27 West of the 6<sup>th</sup> P.M., Cherry County, Nebraska).
