Councilmember Ward made a motion, seconded by Kieborz, to approve the request by Robert Joseph for special designated liquor licenses for the parking lot of the Peppermill at 502 East Highway 20 on May 11, 2013 from 3:00 p.m. to 1:00 a.m., June 1st, 2013 from 3:00 p.m. to 1:00 a.m., and June 29th, 2013 from 3:00 p.m. to 1:00 a.m.

The request by Loretta Wells to vacate Lodi Street spur was tabled to the next regular meeting.

Councilmember Kieborz made a motion, seconded by Nelsen, to approve the Economic Development Program Loan in the amount of \$100,000.00 for 60 months at 4% per year interest to Adam Anderson and Kelly Russell to buy Peterson Dental Clinic. Voting aye: Kieborz, Sadi, Nelsen, Ward. Abstain: Arganbright. Motion carried four with one absention.

Councilmember Arganbright made a motion, seconded by Nelsen, to approve the Memorandum of Understanding between the City, its economic development board, the Valentine Chamber of Commerce, and the Cherry County Visitor Promotion Board to commit up to \$5,000.00 from the general fund to develop unified branding for the area and a joint website, and to provide for the future allocation of expenses and maintenance of the website. Voting Aye: Ward, Kieborz, Nelsen, Arganbright, Sadi. Motion carried unanimously.
