A regular meeting of the City Council of the City of Valentine, Valentine, Nebraska was held December 12, 2013 at 7:00 p.m. in the Valentine City Library Meeting Room, the same notice of meeting was given according to law. All of the proceedings hereafter shown were taken while the meeting was open to the public. A Public Information Council Agenda packet was available at the public information table. Notice of the Open Meetings Act was provided as required by law.

No action was taken concerning the remodel of the city hall garage.
