A regular meeting of the City Council of the City of Valentine, Nebraska was held April 13, 2017 at 7:00 p.m. in the City Library Meeting Room, the same notice of meeting was given according to law. All of the proceedings hereafter shown were taken while the meeting was open to the public. A Public Information Council Agenda packet was available at the public information table. Notice of the Open Meetings Act was provided as required by law.

The Council and those in attendance recited the pledge of allegiance.

Chairperson of the Council Kyle Arganbright opened the meeting with the following Council members in attendance: Dave Otradovsky, Neil Wescott, Andrew Ward, Kalli Kieborz. Also in attendance were City Manager Shane Siewert and Deanna Schmit, City Clerk, recorded the minutes.

Council exited closed session at 8:14 p.m.

Councilmember Arganbright made a motion, seconded by Otradovsky, to select Heartland Consumer Power District for further negotiations for the city power provider. Voting aye: Otradovsky, Ward, Kieborz, Wescott, Arganbright. Motion carried unanimously.
