Notice of the Open Meetings Act was provided as required by law.

The Council and those in attendance recited the pledge of allegiance.

Chairperson of the Council Kyle Arganbright opened the meeting with the following Council members in attendance: Neil Wescott, Andrew Ward, Dave Otradovsky, Kalli Kieborz. Also in attendance were City Manager Shane Siewert, City Attorney Suzy Beel and Deanna Schmit, City Clerk, recorded the minutes.

Councilmember Wescott made the motion to approve the consent agenda items: #2a) Regular Library Board meeting minutes of October 23, 2017; #3a) Regular Meeting of October 12, 2017; #4 September, 2017 Financial Reports; #5 October, 2017 Receipt Report; #6 Octoberber, 2017 Claims & Payroll. Voting aye: Arganbright, Otradovsky Kieborz, Wescott. Voting no: Ward. Motion carried four to one. No action was taken concerning the Economic Development Board's request to commit \$100,000.00 in LB840 funds as matching funds for CNEDD's application for workforce housing grant money from the State of Nebraska.

Councilmember Arganbright made a motion, seconded by Kieborz, to adopt the Resolution reducing the golf board to five members. Voting aye: Otradovsky, Ward, Kieborz, Arganbright. Voting no: Wescott. Motion carried four to one.

Councilmember Kieborz made a motion, seconded by Arganbright, to appoint Regina Osburn to the golf board for remainder of Kurt Arganbright's term. Voting aye: Otradovsky, Arganbright, Kieborz, Ward. Voting no: Wescott. Motion carried four to one.

Councilmember Otradovsky made a motion, seconded by Arganbright, to approve the wholesale power agreement for firm full requirements service with Heartland Consumers Power District. Voting aye: Wescott, Arganbright, Kieborz, Otradovsky. Voting no: Ward. Motion carried four to one.

There being no further business before the council, Council Chairperson Arganbright declared the meeting adjourned at 8:07 p.m.
