A regular meeting of the City Council of the City of Valentine, Nebraska was held March 8, 2018 at 7:00 p.m. in the City Library Meeting Room, the same notice of meeting was given according to law. All of the proceedings hereafter shown were taken while the meeting was open to the public. A Public Information Council Agenda packet was available at the public information table. Notice of the Open Meetings Act was provided as required by law.

The Council and those in attendance recited the pledge of allegiance.

Chairperson of the Council Kyle Arganbright opened the meeting with the following Council members in attendance: Neil Wescott, Kalli Kieborz, Dave Otradovsky and Andrew Ward. Also in attendance were City Manager Shane Siewert and Deanna Schmit, City Clerk, recorded the minutes.

Councilmember Wescott made the motion to approve the consent agenda items: #2a) Regular Library Board meeting minutes of February 26, 2018; #3a) Regular City Council Meeting minutes of February 8, 2018; #4 January, 2018 Financial Reports; #5 February, 2018 Receipt Report; #6 February, 2018 Claims & Payroll. No action was taken concerning the feral cat problem.

7:15 p.m. Pursuant to notice in Midland News and Printing a public hearing was opened for the purpose of reviewing the City of Valentine Six Year Road Improvement Program.

7:42 p.m. Public hearing to review the Six Year Road Improvement Program was closed.

Councilmember Otradovsky made a motion, seconded by Arganbright, to approve the application for a liquor license by Casey's General Store. Voting aye: Kieborz, Wescott, Arganbright, Otradovsky, Ward. Motion carried unanimously.

Councilmember Arganbright made a motion, seconded by Otradovsky, to adopt the Resolution to approve the City of Valentine Six Year Road Plan for 2018. Voting aye: Wescott, Arganbright, Otradovsky, Kieborz. Voting no: Ward. Motion carried four to one.

Councilmember Wescott made a motion, seconded by Kieborz, to authorize requesting bids for armor coat projects. Voting aye: Arganbright, Otradovsky, Ward, Kieborz, Wescott. Motion carried unanimously.

Councilmember Otradovsky made a motion, seconded by Arganbright, to adopt the Resolution to sell surplus personal property consisting of 10 pieces of Nautilus fitness equipment. Voting aye: Wescott, Ward, Arganbright, Kieborz, Otradovsky. Motion carried unanimously.

There being no further business before the council, Council Chairperson Arganbright declared the meeting adjourned at 8:23 p.m.
